AGREEMENT

The _____ ("Sponsor")
Wishes to sponsor _____ in order to participate in
"Hortensia" They Hydrangea Project through Creative Arts Network Inc. Sponsor-A-Spot Program. As such, we agree to
the following terms and conditions, set forth below:

1. The undersigned party agrees that they will accept responsibility to maintain and clean-up the above stated space on a weekly maintenance with a minimum of once per month clean-up efforts throughout the spring through fall months minimum of once per month during the months of April through November, including participation of the annual city-wide clean-ups.
2. The undersigned party agrees to commit a minimum of two years to such activities.
3. The Sponsor Supervisor shall coordinate clean-up days and landscaping or tree planting installation with Creative Arts Network Inc. (CAN) and shall notify CAN of the clean-up day when garbage pick-up is needed.
4. The Sponsor will separate the yard waste (branches, leaves, mulch, etc) and place in a separate container from regular trash.
5. The Sponsor will be responsible for the caring of planted trees by watering, mulching, fertilizing and protective plastic around the base. The Sponsor shall provide themselves with all necessary tools or landscaping materials to be used within the park, and any such landscaping will become the property of the city. The sponsor can also utilize the cities Tool Shed and sign out tools for clean up's by contacting the Dept. of Community Maintenance.
6. The Sponsor agrees to work only daylight hours and in appropriate weather.
7. The Sponsor agrees to wear protective clothing including work gloves, sturdy shoes, any open-style footwear will not be permitted, long sleeved shirts and pants to prevent injury from objects, insects, sunburn, and poison ivy.
8. The Sponsor agrees to not overexert themselves, drink plenty of water and take breaks as needed.
9. The Sponsor agrees to provide adequate supervision of participants under the age of 18.
10. The Sponsor agrees to avoid toxic or hazardous substances such as poison ivy, poison oak or any other poison substances, areas where herbicides have been placed, animals.
11. The Sponsor agrees to avoid hazardous areas such as busy roads, parking lots, boat accesses, construction sites, and areas where mowing or other maintenance activities are in progress.
12. The Sponsor agrees to use caution in handling collected trash items, not to crush collected items or pick up broken, jagged, or hazardous items that could cause injury, and to notify city staff of these items.
13. The Sponsor agrees not to pick up or touch any syringe and must call the Fall River Police Dept. to dispose of such items.
14. The Sponsor is responsible for having a first aid kit available at every clean-up.
15. All volunteers will agree to CORI check.
